IT IS IMPORTANT THAT YOU READ THE RULES AND REGULATIONS

All dealers must be registered. There can be no more than two dealers per booth.

The rule of two people per booth applies to set-up day as well as show day. If you require additional help for any reason, please register the names with the promoters prior to set-up day. (Additional help is limited to two people per booth with promoter's permission)

REPRODUCTIONS

No new merchandise is permitted. Antiques and collectibles should be no less than 40 years old. We want to have a quality show! The dealer must accept the Management's judgment on all disputed items or merchandise.

SALE SIGNS/PRICING

All merchandise must be priced. NO SALE SIGNS - DISCOUNT SIGNS ALLOWED

SALES TAX

All dealers are to collect Indiana Sales Tax and must hold a valid Indiana Sales Tax number. It is important to list your Indiana Sales Tax number on your contract. If you do not have a Sales Tax number we will give you an application.

SET-UP HOURS

Upon arrival and before set-up, report to staff near front entrance for registration and final

payment. Friday - 9:30 AM TO 6 PM (Chicago time)

You must be set up and in place by 6:00 PM Friday as the staff leaves promptly at 6:00 PM and the security officer is then in charge, locking all buildings. You may set up Saturday between 6:00 AM – 8 AM.

<u>CANCELLATION</u>: A \$10.00 service fee is charged for all show cancellations. A dealer who fails to show forfeits all fees due No refunds are given for any cancellations the week prior to the show. No refunds on tables that are reserved.

SPACE ASSIGNMENT: To retain your current booth space for the next year's show, we must receive

your contract by **September 1st**, or we cannot guarantee the same booth space.

NO EARLY PACKING

Please refrain from packing up early. We promise the public a full show no matter when they arrive.

LOADING & UNLOADING

You cannot drive into the building to unload.

SOLICITATION

Permission must be acquired from the promoters of this show before any solicitation verbal or written is done.

ADDITIONAL SPACE

It has been decided by the promoters that if you have space along a wall next to your booth (inside or outside) you may negotiate with the promoters for the rent of that additional space.
